Personal Care with ADL

MHHC provide assistance with Activities of Daily Living (ADLs) which include all things involved in personal care, that include getting ready for the day or getting ready for sleep. These activities include –

Personal Care with IADL

MHHC provide assistance with Instrumental Activities of Daily Living (IADL) which are activities that are carried out daily to take care of you and your home. These include;

- Light housekeeping

- Light meal preparation
- Escort to errands and grocery shopping
